# **ArtsRaise Conference 2023 Subsidy EOI** Guidelines

### 1. About the opportunity

ArtsRaise is a new arts and culture fundraising conference presented by Fundraising and Philanthropy (F&P).

The conference will gather arts fundraising professionals, sponsors, philanthropists, and foundations over two days in Melbourne on 28 and 29 March 2023.

Participants will learn fundraising best practices. inspirational case studies, emerging methods, thought leadership and more from some of Australia's leading arts and cultural organisations and practitioners.

## 2. Eligibility criteria

**A.** Applicants must be:

• employed in a role that includes responsibility for fundraising or development.

**B.** Applicant organisations must:

- be based in Australia and carrying out most of their arts activity or practice within Australia;
- be a legally constituted entity (with an ABN);
- be registered as a not-for-profit organisation, as defined by the Australian Taxation Office (ATO)1:
- have an annual turnover of less than \$5 million in the previous financial year;
- be operating with the primary purpose of providing arts and cultural opportunities for Australian artists and audiences:

This program will **not** accept EOI's from:

organisations with an annual turnover of \$5 million or more.

After the conference, participants will be required to complete an evaluation of the outcomes of their experience and the value of the opportunity. Full participation in the evaluation process is a condition of accepting the subsidy. Participants will not be eligible for future CPA programs until this has been completed.

EOI opens: 17 November at 12pm AEDT EOI closes: 20 December at 12pm AEDT

**Assessment**: January 2023

Applicants notified: February 2023

ArtsRaise Melbourne: 28 – 29 March 2023

#### 3. Assessment

All expressions of interest (EOI) must outline:

- Your organisation's primary purpose;
- Your organisation's fundraising activities and challenges;
- How you and your organisation would benefit from your attendance at ArtsRaise, and which particular sessions would be of benefit and why?
